About this PDS

This Product Disclosure Statement ("PDS") has been prepared and issued by Equity Trustees Limited ("Equity Trustees", "we" or "Responsible Entity") and is a summary of the significant information relating to an investment in the Lincoln Australian Income Fund (the "Fund"). It contains a number of references to important information (including a glossary of terms) contained in the Lincoln Australian Income Fund Reference Guide ("Reference Guide"), each of which forms part of this PDS. The Fund is comprised of two classes of units: Lincoln Retail Australian Income Fund (APIR code: ETL0323AU), which is a retail class; and Lincoln Wholesale Australian Income Fund (APIR code: ETL0324AU), which is a wholesale class. Wholesale Clients are also able to invest in the Lincoln Retail Australian Income Fund, however Retail Clients are unable to invest in the Lincoln Wholesale Australian Income Fund. You should carefully read and consider both the information in this PDS, and the information in the Reference Guide, before making a decision about investing in the Fund.

The information provided in this PDS is general information only and does not take account of your personal objectives, financial situation or needs. You should obtain financial and taxation advice tailored to your personal circumstances and consider whether investing in the Fund is appropriate for you in light of those circumstances.

The offer to which this PDS relates is only available to persons receiving this PDS (electronically or otherwise) in Australia.

This PDS does not constitute a direct or indirect offer of securities in the US or to any US Person as defined in Regulation S under the Securities Act of 1933 as amended ("US Securities Act"). Equity Trustees may vary this position and offers may be accepted on merit at Equity Trustees' discretion. The Responsible Entity

Equity Trustees Limited ABN 46 004 031 298 AFSL 240975, a subsidiary of EQT Holdings Limited ABN 22 607 797 615, which is a public company listed on the Australian Securities Exchange (ASX: EQT), is the Fund's responsible entity and issuer of this PDS. Established as a trustee and executorial service provider by a special Act of the Victorian Parliament in 1888, today Equity Trustees is a dynamic financial services institution which continues to grow the breadth and quality of products and services on offer.

Equity Trustees' responsibilities and obligations as the Fund's responsible entity are governed by the Fund's Constitution ("Constitution"), the Corporations Act and general trust law. Equity Trustees has appointed Lincoln Indicators Pty Ltd as the investment manager of the Fund. Equity Trustees has appointed a custodian to hold the assets of the Fund. The custodian has no supervisory role in relation to the operation of the Fund and is not responsible for protecting your interests.

The Investment Manager

Lincoln Indicators Pty Ltd

Lincoln Indicators Pty Ltd ("Lincoln" or "Investment Manager") is the investment manager of the Fund. Lincoln also separately manages the Lincoln Australian Growth Fund and the Lincoln U.S. Growth Fund(s). Lincoln's unique investment strategy leverages off its core quantitative models to develop portfolios suitable for Australian investors to assist in meeting their equity investment objectives. The funds managed by Lincoln are backed by Lincoln's academically-developed "Financial Health" methodology as well as Lincoln's experienced and dedicated team of investment professionals.

Founded in 1984 by esteemed academic and Olympian Dr Merv Lincoln, Lincoln was established as a consultancy business. Dr Lincoln's son Tim Lincoln, joined the business in 1991 and became Managing Director of Lincoln in 1997. Tim is the Executive Chairman and Chief Investment Officer for the managed fund business. Lincoln have been providing investment management solutions for Australian investors since 2003, and have organically grown their funds under management to over \$700m.

2. How the Lincoln Australian Income Fund works

The Fund is a registered managed investment scheme governed by the Constitution. The Fund comprises assets which are acquired in accordance with the Fund's investment strategy. Direct investors receive units in the relevant class of the Fund when they invest.

The Fund is comprised of two classes of units: Lincoln Wholesale Australian Income Fund, which is a wholesale class, and Lincoln Retail Australian Income Fund, which is a retail class. In general, each unit represents an equal interest in the assets referable to the relevant class of the Fund subject to liabilities; however,

it does not give investors an interest in any particular asset of the Fund.

If you invest in the Fund through an IDPS (as defined in the Reference Guide) you will not become an investor in the Fund. The operator or custodian of the IDPS will be the investor entered in the Fund's register and will be the only person who is able to exercise the rights and receive the benefits of a direct investor. Your investment in the Fund through the IDPS will be governed by the terms of your IDPS. Please direct any queries and requests relating to your investment to your IDPS Operator. Unless otherwise stated, the information in the PDS applies to direct investors.

Applying for units

You can acquire units by completing an online application form (see section 8 for details) or the Application Form that accompanies this PDS. The minimum initial investment amount for the Lincoln Wholesale Australian Income Fund is \$250,000 and the Lincoln Retail Australian Income Fund is \$5,000.

You can apply using the following options: Electronic Funds Transfer ("EFT") and also via cheque. Please refer to the Reference Guide for more information.

We reserve the right to accept or reject applications in whole or in part at our discretion. We have the discretion to delay processing applications where we believe this to be in the best interest of the Fund's investors.

The price at which units are acquired is determined in accordance with the Constitution ("Application Price"). The Application Price on a Business Day is, in general terms, equal to the Net Asset Value ("NAV") of the class, divided by the number of units on issue for that class and adjusted for transaction costs ("Buy Spread"). At the date of this PDS, the Buy Spread is 0.25%.

The Application Price will vary as the market value of assets in the class rises or falls.

Making additional investments

You can make additional investments into the class at any time by sending us your additional investment amount together with a completed Application Form or via BPAY[®]. You can also invest on a monthly basis via a direct debit payment as a Regular Savings Plan ("RSP") for as little as \$250 per month (please refer to the Reference Guide for more information). The minimum additional investment into the Lincoln Wholesale Australian Income Fund is \$5,000 and the Lincoln Retail Australian Income Fund is \$1,000.

Distributions

An investor's share of any distributable income is calculated in accordance with the Constitution and is generally based on the number of units held by the investor at the end of the distribution period.

The Fund usually distributes income quarterly at the end of March, June, September and December, however, Equity Trustees may change the distribution frequency without notice. Distributions are calculated effective the last day of each distribution period and are normally paid to investors as soon as practicable after the distribution calculation date.

Investors in the Fund can indicate a preference to have their distribution:

- reinvested back into the Fund; or
- directly credited to their AUD Australian domiciled bank account.

Investors who do not indicate a preference will have their distributions automatically reinvested. Applications for reinvestment will be taken to be received immediately prior to the next Business Day after the relevant distribution period. There is no Buy Spread on distributions that are reinvested.

In some circumstances, the Constitution may allow for an investor's withdrawal proceeds to be taken to include a component of distributable income.

Indirect Investors should review their IDPS Guide for information on how and when they receive any income distribution.

Access to your money

Investors in the Fund can generally withdraw their investment by completing a request within the investor portal online or completing the Redemption Request Form and mailing it to:

Please note that the Redemption Request Form can be accessed in the 'forms' section of the Lincoln Web Portal.

The minimum withdrawal amount for both the Lincoln Wholesale Australian Income Fund and the Lincoln Retail Australian Income Fund is \$1,000. For written withdrawal requests, once we receive and accept your withdrawal form, we may act on your instruction without further enquiry if the instruction bears your account number or investor details and your (apparent) signature(s), or your authorised signatory's (apparent) signature(s). If your withdrawal request is completed through the Lincoln Web Portal, then we may act on your instruction without further enquiry as the verification is completed electronically.

Equity Trustees will generally allow an investor to access their investment within 7 days of acceptance of a withdrawal request by transferring the withdrawal proceeds to such investor's nominated AUD Australian domiciled bank account. However, Equity Trustees is allowed to reject withdrawal requests in certain circumstances, and also to make payment up to 30 days after acceptance of a request (which may be extended in certain circumstances) as outlined in the Constitution and Reference Guide

The price at which units are withdrawn is determined in accordance with the Constitution ("Withdrawal Price"). The Withdrawal Price on a Business Day is, in general terms, equal to the NAV of the class, divided by the number of units on issue for that class and adjusted for transaction costs ("Sell Spread"). At the date of this PDS, the Sell Spread is 0.25%.

The Withdrawal Price will vary as the market value of assets in the class rises or falls.

Equity Trustees reserves the right to fully redeem your investment if your investment balance falls below \$250,000 in the Lincoln Wholesale Australian Income Fund or below \$5,000 for the Lincoln Retail Australian Income Fund (or any such other amount as determined by the Responsible Entity from time to time), as a result of processing your withdrawal request. In certain circumstances, for example, when there is a freeze on withdrawals, where accepting a withdrawal is not in the best interests of investors in the Fund including due to one or more circumstances outside its control or where the Fund is not liquid (as defined in the Corporations Act), Equity Trustees can deny or suspend a withdrawal request and you may not be able to withdraw your funds in the usual processing times or at all. When the Fund is not liquid, an investor can only withdraw when Equity Trustees makes a withdrawal offer to investors in accordance with the Corporations Act. Equity Trustees is not obliged to make such offers.

If you are an Indirect Investor, you need to provide your withdrawal request directly to your IDPS Operator. The time to process a withdrawal request will depend on the particular IDPS Operator and the terms of the IDPS.

Unit pricing discretions policy

Equity Trustees has developed a formal written policy in relation to the guidelines and relevant factors taken into account when exercising any discretion in calculating unit prices (including determining the value of the assets and liabilities). A copy of the policy and, where applicable and to the extent required, any other relevant documents in relation to the policy will be made available free of charge on request.

Additional information

If and when the Fund has 100 or more direct investors, it will be classified by the Corporations Act as a 'disclosing entity'. As a disclosing entity, the Fund will be subject to regular reporting and disclosure obligations. Investors would then have a right to obtain a copy, free of charge, of any of the following documents:

- the most recent annual financial report lodged with ASIC ("Annual Report");
- any subsequent half yearly financial report lodged with ASIC after the lodgement of the Annual Report; and
- any continuous disclosure notices lodged with ASIC after the Annual Report but before the date of this PDS.

Equity Trustees will comply with any continuous disclosure obligation by lodging documents with ASIC as and when required.

3. Benefits of investing in the Lincoln Australian Income Fund

Income from your investment – as well as seeking capital growth through an increase in unit prices, the Fund aims to provide investors with an income payment – in the form of a quarterly distribution. The Fund has the potential to provide investors with a higher than market level of income compared to the benchmark over the longer term.

Access to sharemarket opportunities – investing in the Fund will provide exposure to a range of listed Australian companies, which an individual investor with limited funds for investment may not otherwise be able to obtain. This diversification is intended to reduce risk and exposure and increase stability.

Professional investment expertise – investing in the Fund enables investors to take advantage of the team of research and investment professionals at Lincoln. Your investment will be expertly managed by Australian equity specialists who bring a wealth of experience to the investment management process.

Freedom from administrative burden – investing in the Fund helps to free investors from the burden of ongoing paperwork and regular monitoring required when directly investing in sharemarkets. Investors will be provided with consolidated, comprehensive reports on the performance of the classes of units of the Fund.

Fees - the Fund does not charge establishment, contribution or exit fees.

Time efficient – for investors who would like to outsource the work involved in direct investing and be able to access Lincoln's fundamental "Financial Health" methodology.

4. Risks of managed investment schemes

All investments carry risks. Different investment strategies may carry different levels of risk, depending on the assets acquired under the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk. The significant risks below should be considered in light of your risk profile when deciding whether to invest in the Fund. Your risk profile will vary depending on a range of factors, including your age, the investment time frame (how long you wish to invest for), your other investments or assets and your risk tolerance.

The Responsible Entity and the Investment Manager do not guarantee the liquidity of the Fund's investments, repayment of capital or any rate of return or the Fund's investment performance. The value of the Fund's investments will vary. Returns are not guaranteed and you may lose money by investing in the Fund. The level of returns will vary and future returns may differ from past returns. Laws affecting managed investment schemes may change in the future. The structure and administration of the Fund is also subject to change.

In addition, we do not offer advice that takes into account your personal financial situation, including advice about whether the Fund is suitable for your circumstances. If you require personal financial or taxation advice, you should contact a licensed financial adviser and/or taxation adviser.

Company specific risk

There may be instances where the value of a company's securities will fall because of company specific factors (for example, where a company's major product is subject to a product recall). The value of a company's securities can also vary because of changes to management, product, distribution or the company's business environment.

Derivatives risk

Generally, in the case of derivatives, fluctuations in price will reflect movements in the underlying assets, reference rate or index to which the derivatives relate. The use of derivatives to hedge the risk of movements in an underlying asset, reference rate or index involves 'basis risk', which refers to the possibility that derivatives may not move perfectly in line with the underlying asset, reference rate or index. As a consequence, derivatives cannot be expected to perfectly hedge the risk of the underlying asset, reference rate or index.

Other risks associated with derivatives may include:

- loss of value because of a sudden price move or because of the passage of time;
- potential illiquidity of the derivative;
- the Fund being unable to meet payment obligations as they arise;
- the counterparty to any derivative contract not being able to meet
- its obligations under the contract; and significant volatility in prices.

Fund risk

As with all managed funds, there are risks particular to the Fund, including the possibility it could terminate, fees and expenses could change and the Responsible Entity and/or the Investment Manager may be replaced. There is also a risk that investing in the Fund may give different results than investing directly in the underlying shares.

This might occur because of income or capital gains accrued in the Fund and the consequence of redemptions by other investors.

Interest rate risk

Changes in official interest rates can directly and indirectly impact on investment returns. Generally, an increase in interest rates has a contractionary effect on the state of the economy and the valuation of securities. For example, rising interest rates can have a negative impact on a company's value as increased borrowing costs may cause earnings to decline.

As a result, the company's share price may fall.

Investment selection risk

The Investment Manager may make poor investment decisions resulting in substandard returns (for example, where the Investment Manager invests in a company that significantly underperforms relative to the sharemarket). This risk is mitigated to some extent by the knowledge and experience of the Investment Manager.

Legal risk

There is a risk that laws, including tax laws or laws affecting registered managed investment schemes, might change or become difficult to enforce. This risk is generally higher in emerging markets (in which the Fund does not invest).

Liquidity risk

There may be times when investments may not be readily realised (for example, in a falling market where some traded securities may become less liquid). However, trading volumes of investments are generally sufficient to satisfy liquidity requirements when necessary. The Investment Manager attempts to mitigate the liquidity risk factor by ensuring that the Fund has sufficient cash exposure to meet liquidity requirements. Note that neither the Responsible Entity nor the Investment Manager guarantees the liquidity of the Fund's investments.

Market risk

Changes in legal and economic policy, political events, technology failure, economic cycles, investor sentiment and social climate can all directly or indirectly create an environment that may influence (negatively or positively) the value of your investment in the Fund.

Pandemic and other unforeseen event risk

Health crises, such as pandemic and epidemic diseases, as well as other catastrophes that interrupt the expected course of events, such as natural disasters, war or civil disturbance, acts of terrorism, power outages and other unforeseeable and external events, and the public response to or fear of such diseases or events, have and may in the future have an adverse effect on the economies and financial markets either in specific countries or worldwide and consequently on the value of the Fund's investments. Further, under such circumstances the operations, including functions such as trading and valuation, of the Investment Manager and other service providers could be reduced, delayed, suspended or otherwise disrupted.

Regulatory risk

This is the risk that domestic laws or regulations are changed adversely or that regulatory supervision of transactions and reporting is performed by the Investment Manager at less than an appropriate standard. The Investment Manager aims to manage this risk by regularly and closely reviewing changes in the regulatory environment.

5. How we invest your money

Warning: When choosing to invest in the Fund or an option of the Fund, you should consider the likely investment returns, the risks of investing and your investment time frame.

The Fund invests in a range of securities, predominately listed on the ASX. These securities include:

- Australian equities
- Exchange Traded funds (ETFs)
- Hybrid securities
- Corporate bonds

Derivatives trading can be undertaken around the underlying portfolio holdings in an attempt to generate additional income.

The relevant information below applies in relation to both the Lincoln Retail Australian Income Fund and the Lincoln Wholesale Australian Income Fund.

Investment objective

Over the medium to long term, the Fund aims to provide its investors with:

- income above the yield of the Benchmark (see below);
- some capital.

Benchmark

S&P/ASX 200 Accumulation Index (including franking credits)

Minimum suggested time frame

The minimum suggested timeframe for the Fund is 5 years.

Risk level

High. There is a risk investors may lose some or all of their investment. Higher risk investments tend to fluctuate in the short term but can produce higher returns than lower risk investments over the long term.

Investor suitability

- Suitable for investors seeking predominately income returns
- Given the Fund's bias towards fully franked dividends, it particularly suits investors paying below the corporate tax rate
- Suitable for investors with an investment horizon of at least five (5) years. Investors should be comfortable with periods of high volatility.

Investment style and approach

The unique Lincoln research methodology involves rigorous analysis of company fundamentals to assess each prospective investment's Financial Health and strength. Drawing on both quantitative and qualitative research, Lincoln screens a broad range of companies listed on the ASX, including trusts that invest in listed shares.

The Lincoln investment process involves the assessment of the Financial Health of the business – an adapted insolvency risk model which aims to measure a company's financial quality. Only stocks and/ or bonds/hybrids issued by a company that passes Lincoln's Financial Health model can be considered for inclusion in the Fund.

Other quantitative and qualitative factors considered for stocks include the following but not limited to:

- historical & forecasted yield;
- market liquidity;
- capital efficiency (Return on Equity, Return on Assets & Return on Investment Capital); and
- · dividend sustainability.

Lincoln's research department will conduct further active risk assessments to determine the stock's suitability for inclusion in the portfolio.

The Investment Manager may also employ portfolio optimisation measures to produce favourable risk-adjusted returns. This may include hedging market risk by investing in Exchange Traded Funds (ETFs) that buy or sell derivative instruments which intend to produce returns that are inversely correlated with specific equity market indices, such as the Fund's benchmark. Investing in these ETFs allows the Investment Manager to efficiently reduce portfolio beta (risk) if they anticipate future market volatility. The investment in ETFs is intended to be for hedging purposes only.

Asset allocation

The asset allocation target for the Fund is stated in the table below. While the target reflects the intended asset allocation at any time, from time to time, prevailing market conditions or liquidity requirements may see the Fund alter its asset allocation.

Derivatives such as futures, options, swaps and forward rate agreements may be used, but these will not be used to gear the Fund's assets.

Changing the investment strategy

The investment strategy and asset allocation parameters may be changed. If a change is to be made, investors in the Fund will be notified in accordance with the Corporations Act.

Labour, environmental, social and ethical considerations

Equity Trustees and Lincoln do not specifically take into account labour standards or environmental, social or ethical considerations for the purposes of selecting, retaining or realising investments.

6. Fees and costs

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns.

For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.

You may be able to negotiate to pay lower fees. Ask the fund or your financial adviser.

Additional explanation of Fees and Costs

Management fees and costs

The management fees and costs include amounts payable for administering and operating the Fund, Investing the assets of the Fund, expenses and reimbursements in relation to the Fund and indirect costs if applicable.

Management fees and costs do not include performance fees or transaction cots which are disclosed separately.

The management fees component of management fees and costs of 1.75% p.a. of the NAV of the Retail Class and 0.95% p.a. of the NAV of the Wholesale Class is payable to the Responsible Entity of the Fund for managing the assets and overseeing the operations of the Fund. The management fees component is accrued daily and paid from the class monthly in arrears and reflected in the unit price. As at the date of this PDS, the management fees component covers certain ordinary expenses such as Responsible Entity fees, investment management fees, custodian fees and administration and audit fees.

The indirect costs and other expenses component of 0.00% p.a. of the NAV of the Fund may include other ordinary expenses of operating the Fund, as well as management fees and costs (if any) arising from interposed vehicles in or through which the Fund invests. The indirect costs and other expenses component is variable and reflected in the unit price of the Fund as the relevant fees and costs are incurred. They are borne by investors, but they are not paid to the Responsible Entity or Investment Manager. The indirect costs and other expenses component is based on the relevant costs incurred during the financial year ended 30 June 2022.

Transaction costs

In managing the assets of the Fund, the Fund may incur transaction costs such as brokerage, buy-sell spreads in respect of the underlying investments of the Fund, settlement costs, clearing costs and applicable stamp duty when assets are bought and sold. Transaction costs also include costs incurred by interposed vehicles in which the Fund invests (if any), that would have been transaction costs if they had been incurred by the Fund itself. Transaction costs are an additional cost to the investor where they are not recovered by the Buy/Sell Spread, and are generally incurred when the assets of the Fund are changed in connection with day-to-day trading or when there are applications or withdrawals which cause net cash flows into or out of the Fund.




